Mr. Ward: The purpose of today's Meeting is to elect three Members to the Board of Supervisors. He explained Mr. John Wollard would represent Taylor Morrison with 481 votes. He asked if there were any other members of the public present who planned to vote at today's meeting; there were none.

Mr. Ward explained there were three seats available. He asked for Mr. Wollard's nominations.

Mr. Wollard nominated Karen Goldstein, Jim Turner and Scott Turner.

Mr. Ward asked Mr. Wollard to fill out the ballot, sign it, and return the ballot to himself for tabulation. He explained the two individuals who received the highest number of votes would serve a four-year term and the third individual with the lesser number of votes would serve a two-year term.

Mr. Wollard complied. Mr. Ward reported the number of votes per nominee: Ms. Karen Goldstein and Mr. Jim Turner received 481 votes and would serve four-year terms, while Mr. Scott Turner received 480 votes and would serve a two-year term.
