One would allow us to have virtual meetings in declarations of a state of emergency which could be helpful. We will see if that actually goes through. The law might be catching up with technology. The other one is again they are making a run at changing the limited waiver of sovereign immunity. Currently CDDs are \$200,000 dollars per occurrence and \$300,000 in the aggregate. They want to raise it to \$1 million and add an inflation kicker, so it would be a significant jump in our potential exposure, but it made a run the last five years and it's failed every time, so we will see. I will let you know if those come through.

### A RESOLUTION OF THE BOARD OF SUPERVISORS OF PALERMO COMMUNITY DEVELOPMENT DISTRICT AMENDING THE DATE OF THE PUBLIC HEARING ON THE FISCAL YEAR 2023 PROPOSED BUDGET; PROVIDING FOR SEVERABILITY AND INVALID PROVISIONS; PROVIDING FOR CONFLICT AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Board has previously set the date of the Public Hearing on the Proposed Budget for Fiscal Year 2023 was set for Friday, April 15, 2022; and

**WHEREAS**, the Board desires to change the date of the Public Hearing on the Proposed Budget for Fiscal Year 2023 to Friday, June 17, 2022.

### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF PALERMO COMMUNITY DEVELOPMENT DISTRICT:

**SECTION 1. INCORPORATION OF WHEREAS CLAUSES**. That the foregoing whereas clauses are true and correct and incorporated herein as if written into this Section.

**SECTION 2. REVISED PUBLIC HEARING DATE, TIME, AND LOCATION**. A public hearing on said approved budget is hereby declared and set for the following date, hour, and location:

HOUR:	8:30 A.M.
LOCATION:	Lennar Homes

	Fort Myers, Florida 33966

**SECTION 3. NOTICE OF PUBLIC HEARING**. Notice of this public hearing on the budget shall be published in a newspaper of general circulation in the area of the district once a week for two (2) consecutive weeks, except that the first publication shall not be fewer than 15 days prior to the date of the hearing. The notice shall further contain a designation of the day, time, and place of the public hearing. At the time and place designated in the notice, the Board shall hear all objections to the budget as proposed and may make such changes as the board deems necessary.

**SECTION 4. SEVERABILITY AND INVALID PROVISIONS**. If any one of the covenants, agreements or provisions herein contained shall be held contrary to any express provision of law or contract to the policy of express law, but not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separable from the remaining covenants, agreements or provisions and shall in no way effect the validity of the other provisions hereof.

**SECTION 5. CONFLICT.** That all Sections or parts of Sections of any resolutions, agreements or actions of the Board of Supervisors in conflict are hereby repealed to the extent of such conflict.
