

II. Nominations for Supervisor's (Five Positions)

Mr. Ward asked Mr. Smith to nominate five individuals to serve on the Board of Supervisors. Mr. Smith nominated Mr. Barry Ernst, Mr. Andrew Kollmann, Mr. Thomas Dean, Mr. Theodore Denti, and Mr. Scott Edwards.

III. Casting of Ballots

Mr. Smith provided Mr. Ward with the ballot for review.

IV. Ballot Tabulations and Results

Mr. Ward reviewed the ballot and noted Mr. Barry Ernst had 654 votes, Mr. Andrew Kollmann had 600 votes, Mr. Thomas Dean had 600 votes, Mr. Theodore Denti had 600 votes, and Mr. Scott Edwards had 654 votes. He indicated the two individuals with the highest number of votes (Mr. Ernst and Mr. Edwards) would serve four-year terms while the remaining three individuals would serve two-year terms.
